In reference to above captioned subject, I am sending herewith the copies of Notifications issued by the Department of Municipal Affairs, West Bengal for information.

As per the notification of the Municipal Affairs Department of constitution of the Urban body the entire area of Monoharpur, Mrigala and Dankuni Gram Panchayats and one mouza of Garalgacha Gram Panchayat comprising 2 Gram Panchayat Constituencies (4 Gram Panchayat Seats) have been affected. Dankuni Gram Panchayat is comprised of 13 Gram Panchayat Constituencies (15 Gram Panchayat Seats), 3 Panchayat Samiti Constituencies/ Seats. Monoharpur Gram Panchayat is comprised of 15 Gram Panchayat Constituencies (18 Gram Panchayat Seats), 3 Panchayat Samiti Constituencies/ Seats. Mrigala Gram Panchayat is comprised of 14 Gram Panchayat Constituencies (18 Gram Panchayat Seats), 3 Panchayat Samiti Constituencies/ Seats. In Garalgacha Gram Panchayat the Panchayat Samiti Seat Garalgacha/PS-24 is constituted of 3 Gram Panchayat Constituencies namely Garalgacha/I, Garalgacha/II and Garalgacha/III, effected by the above mentioned notification only Garalgacha/I & Garalgacha/II.

The Chanditala-II/ZP-8 is the affected Zilla Parishad Seat which is comprised of Garalgacha, Monoharpur, Mrigala & Dankuni Gram Panchayats. Hence only the Zilla Parishad Seat will remain comprised of the remaining portion of Garalgacha Gram Panchayat except Mouza Kalipur, JL No.99.

A copy of the detail statement mouza and part wise is also enclosed for your kind perusal.

You are requested to kindly provide the necessary instructions regarding the steps to be taken from this end in respect of the Elected Representatives, Employees, Assets etc. of Monoharpur, Mrigala and Dankuni Gram Panchayats and Elected Representatives of and Assets etc. of Garalgacha/I & Garalgacha/II Constituencies (total 4 GP seats namely Garalgacha/I-1,2 and Garalgacha/II-3,4) of Garalgacha Gram Panchayat from 1st day of November, 2008.


I am directed to state that in all States where polling has been completed, the Commission has decided to allow the following activities, except in the districts where any repoll is pending:
